**Together Announces Proposed Offer of Senior Secured Notes**

13 January 2021

Together Financial Services Limited (“Together” or the “Company”), one of the UK’s leading specialist mortgage and secured loans providers, announces that it intends to offer £450.0 million in aggregate principal amount of Senior Secured Notes due 2027 (the “Notes”), through its wholly owned subsidiary Jerrold FinCo plc (the “Issuer”). The gross proceeds of the offering of the Notes are expected to be used (i) to redeem, in full, the Issuer’s £350.0 million in aggregate principal amount of senior secured notes due 2024, (ii) to reduce drawn balances under the CABS Securitization and (iii) to pay associated fees and expenses.

The Notes will be guaranteed on a senior secured basis by the Company and all subsidiaries of the Company (other than the Issuer, the securitizations entities and certain dormant and non-material subsidiaries) (the “Subsidiary Guarantors,” and, together with the Company, the “Guarantors”). The Notes and the guarantees will be secured by first-priority fixed and floating security interests granted on an equal and rateable first-priority basis over all of the issued capital stock in the Issuer and each of the Subsidiary Guarantors, substantially all of the existing and future property and assets of the Issuer and the Guarantors (excluding the assets sold to the securitisations), and any additional security interests that may in the future be pledged to secure obligations under the Notes, the guarantees and the indenture. Pursuant to the terms of the intercreditor agreement, certain liabilities in respect of indebtedness incurred under the revolving credit facility and certain hedging obligations that are secured by assets that also secure the Issuer's or the Guarantors’ obligations under the Notes or the Guarantees, as applicable, will receive priority with respect to any proceeds received upon any enforcement action over any such assets. The Notes will be general obligations of the Issuer and will rank pari passu in right of payment with all existing and future indebtedness of the Issuer that is not expressly subordinated in right of payment to the Notes, including the Issuer’s £435.0 million in aggregate principal amount of 4<sup>7</sup>/<sub>8</sub>% Senior Secured Notes due 2026, the Revolving Credit Facility and certain hedging obligations (where applicable).

Application will be made to admit the Notes to the Official List of Euronext Dublin and to trading on the Global Exchange Market thereof.

**Trading Update**

Together also provides the following Trading Update for the quarter ended 31 December 2020 (“Q2 ’21”):

- Average monthly loan originations were £74.4 million in Q2 ’21, up 70.6% compared with £43.6 million in the quarter ended 30 September 2020 (“Q1 ’21”)

- Q2 '21 average monthly cash receipts were £142.2 million, compared with £125.7 million in Q1 '21
- Preliminary total accessible liquidity\* increased to £299.8 million at 31 December 2020, compared with £267.2 million at 30 September 2020
- Total cash at 31 December 2020 was £269.3 million (£153.1 million restricted cash and £116.2 million unrestricted cash), compared to £300.5 million (£152.6 million restricted cash and £147.9 million unrestricted cash) at 30 September 2020
- At 31 December 2020 headroom within our facilities was £997 million, compared to £872 million at 30 September 2020
- The Group has continued to support our customers throughout the pandemic, with 23.1% of Group customers by value taking a mortgage payment deferral since the onset of Covid-19 (“MPD Total Loans”)
  - At 31 December 2020, 1.9% of Group customers by value remained within a mortgage payment deferral (‘MPD Live Loans’) compared with 6.2% at 30 September 2020
  - At 31 December 2020 Borrower Group MPD Total Loans were 16% and MPD Live Loans were 1.4% (30 September 2020: 4.5%)
