## **Together Announces Proposed Offer of Senior Secured Notes**

25 March 2024

*This announcement does not constitute an offer to sell or the solicitation of an offer to buy the Notes or any other security and shall not constitute an offer, solicitation or sale in the United States or in any jurisdiction in which, or to any persons to whom, such offering, solicitation or sale would be unlawful prior to registration or qualification under the securities laws of any jurisdiction.*

Together Financial Services Limited (“Together” or the “Company”), one of the UK’s leading non-bank relationship lenders, announces that it intends to offer £450 million in aggregate principal amount of Senior Secured Notes due 2030 (the “Notes”), through its wholly owned subsidiary Jerrold FinCo plc (the “Issuer”). The gross proceeds of the offering of the Notes, together with proceeds from the sale of assets to certain of our securitizations, are expected to be used (i) to redeem, in full, the Issuer’s £555.0 million in aggregate principal amount of the senior secured notes due 2026 issued under an indenture dated February 10, 2020, and (ii) to pay fees and expenses in connection with the offering of the Notes.

The Notes will be guaranteed on a senior secured basis by the Company and all subsidiaries of the Company (other than the Issuer, the subsidiaries comprising the securitizations and certain dormant and non-material subsidiaries) (the “Subsidiary Guarantors,” and, together with the Company, the “Guarantors”). The Notes and the guarantees will be secured by first-priority fixed and floating security interests granted on an equal and rateable first-priority basis over all of the issued capital stock in the Issuer and each of the Subsidiary Guarantors, substantially all of the existing and future property and assets of the Issuer and the Guarantors (excluding the assets sold to the securitisations), an assignment of the notes proceeds loan provided by the Issuer to the Company, and any additional security interests that may in the future be pledged to secure obligations under the Notes, the guarantees and the indenture. Pursuant to the terms of the existing intercreditor agreement and the proposed intercreditor agreement, certain liabilities in respect of indebtedness incurred under the revolving credit facility and certain hedging obligations that are secured by assets that also secure, or will secure, the Issuer’s or the Guarantors’ obligations under the Issuer’s £500.0 million in aggregate principal amount of the senior secured notes due 2027 (“2027 Notes”) and the Notes, as applicable, will receive priority with respect to any proceeds received upon any enforcement action over any such assets. The Notes will be general obligations of the Issuer and will rank *pari passu* in right of payment with all existing and future indebtedness of the Issuer that is not expressly subordinated in right of payment to the Notes, including the 2027 Notes and the revolving credit facility.

Application will be made to The International Stock Exchange Authority Limited (the “Authority”) for the listing of and permission to deal in the Notes on the Official List of The International Stock Exchange (the “Exchange”). There can be no assurance that the Notes will be listed on the Official List of the Exchange, that such permission to deal in the Notes will be granted or that such listing will be maintained.

### **Trading Update**

Together also provides the following Trading Update for the month ended 31 January 2024:

- Monthly originations in the month of January, 2024 were £223.4 million, compared to originations in January 2023 of £192.6 million. Cash receipts in January, 2024 were £216.1 million, compared to cash receipts in January, 2023 of £141.7 million.
- Total Accessible Liquidity\* as of 31 January 2024 was £309.1 million, compared to £326.1 million as of 31 December 2023. As of 31 January 2024, amounts available and undrawn under our Revolving Credit Facility and the Securitizations were £1,581.7 million, compared to £1,439.8 million as of 31 December 2023.
- Total cash as of 31 January 2024 was £355.7 million, comprising of £272.8 million restricted cash and £82.9 million unrestricted cash, compared to £346.6 million, comprising of £288.9 million restricted cash and £57.7 million unrestricted cash as of 31 December 2023.
